



Available Currency Table, Limits and Fee Structures

This document outlines available currencies for Local Currency Delivery, Non Local Currency Delivery and Available Destination Countries for Non Domestic Delivery.

Local Currency Delivery: Available currencies for which a *Sender* can send the *Recipient* funds denominated in the official currency of the Recipient’s country. (ie. sending AUD to an Australian domiciled bank account).
